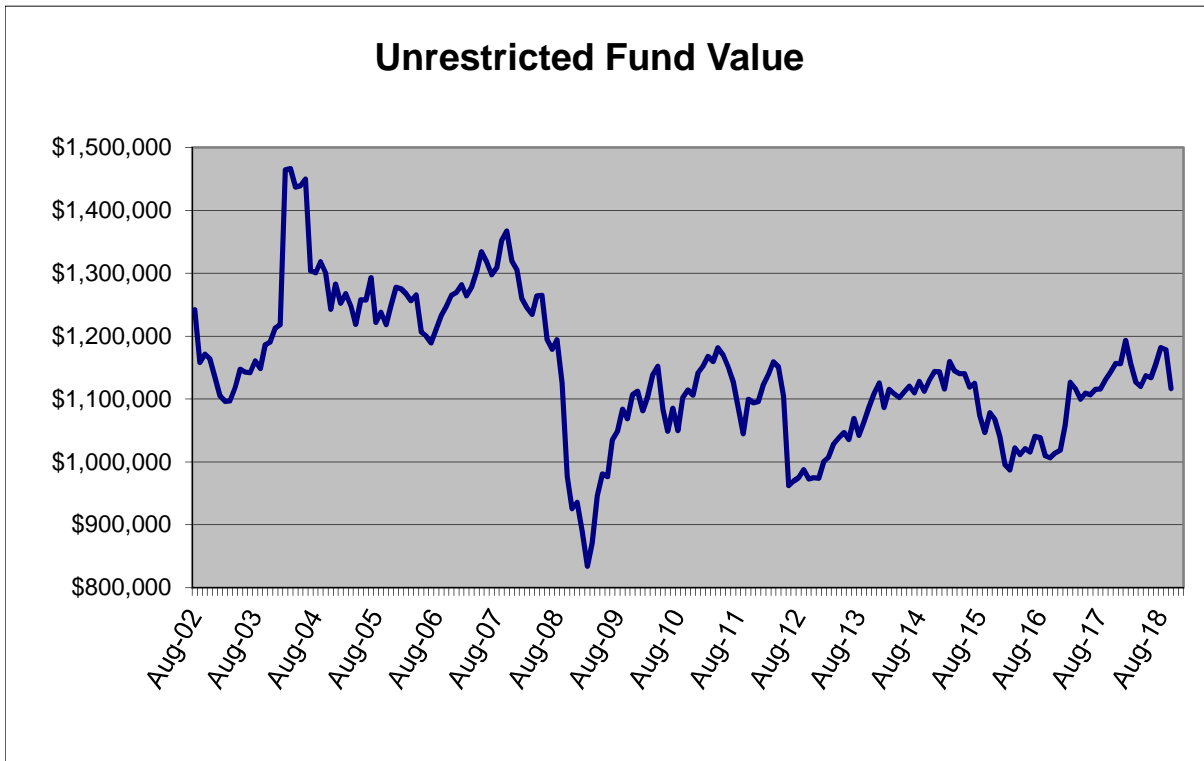
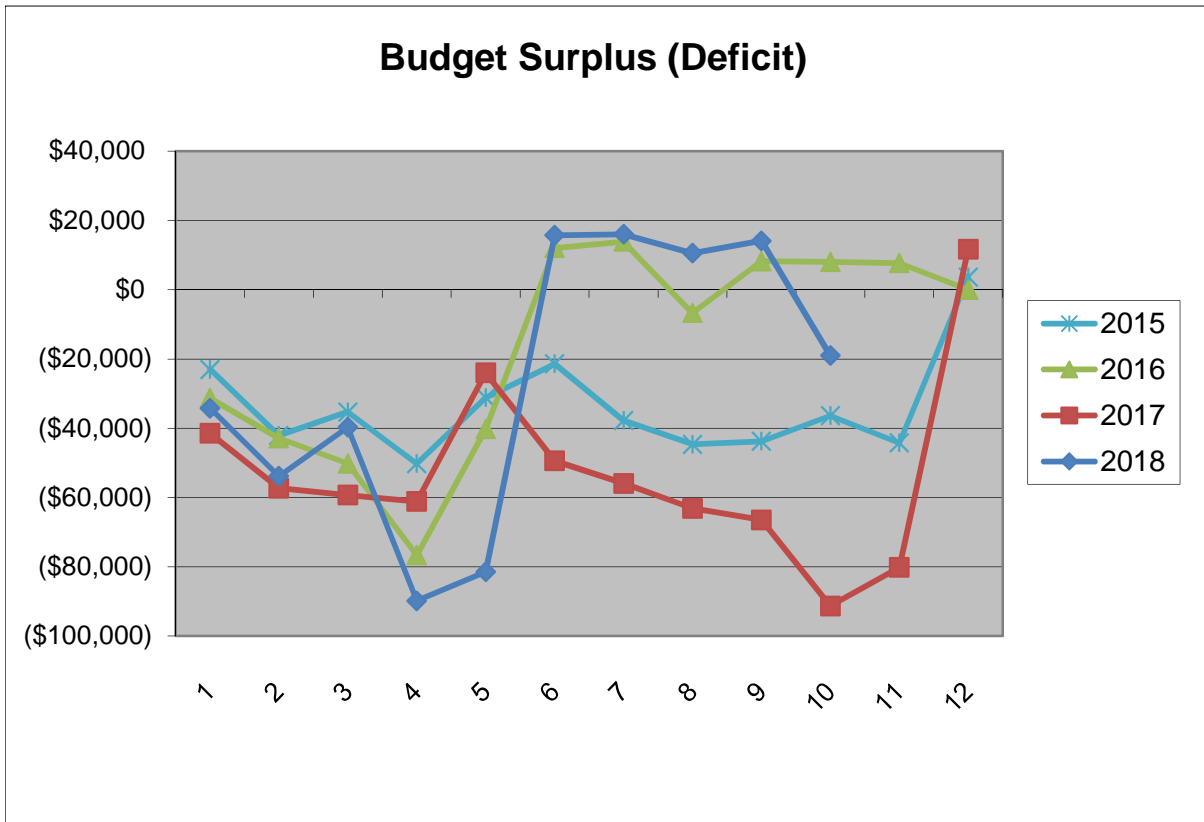
Income Totals



Expense Totals

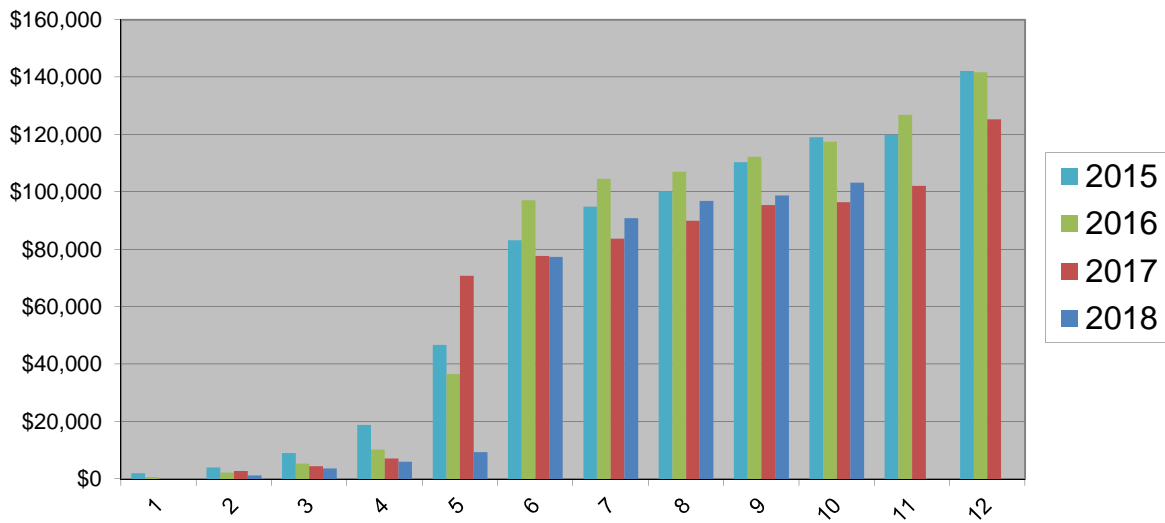

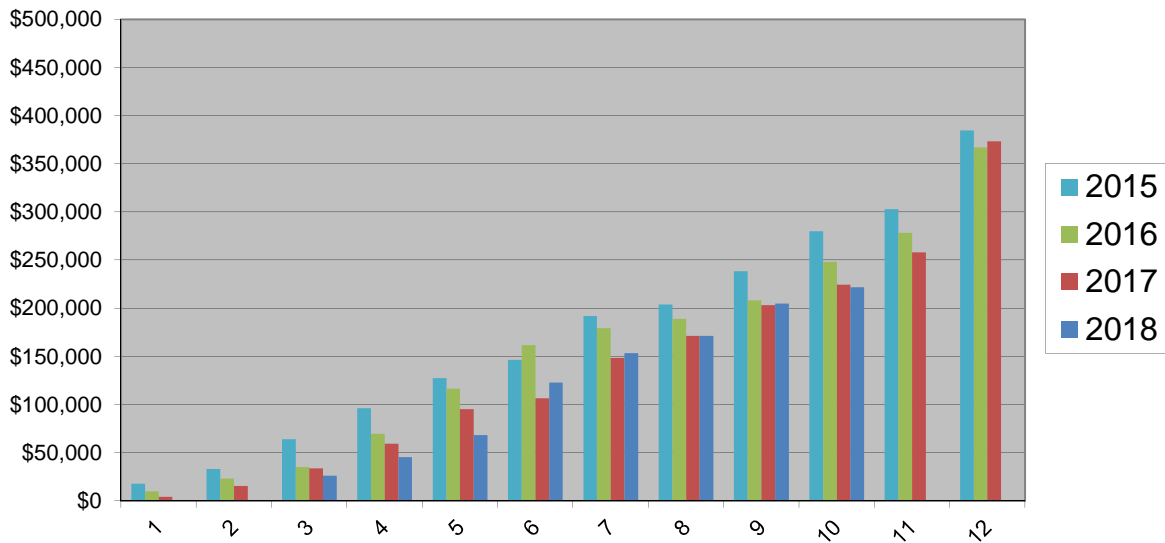


VERMONT CONFERENCE MONTHLY INDICATORS

Per Capita Totals

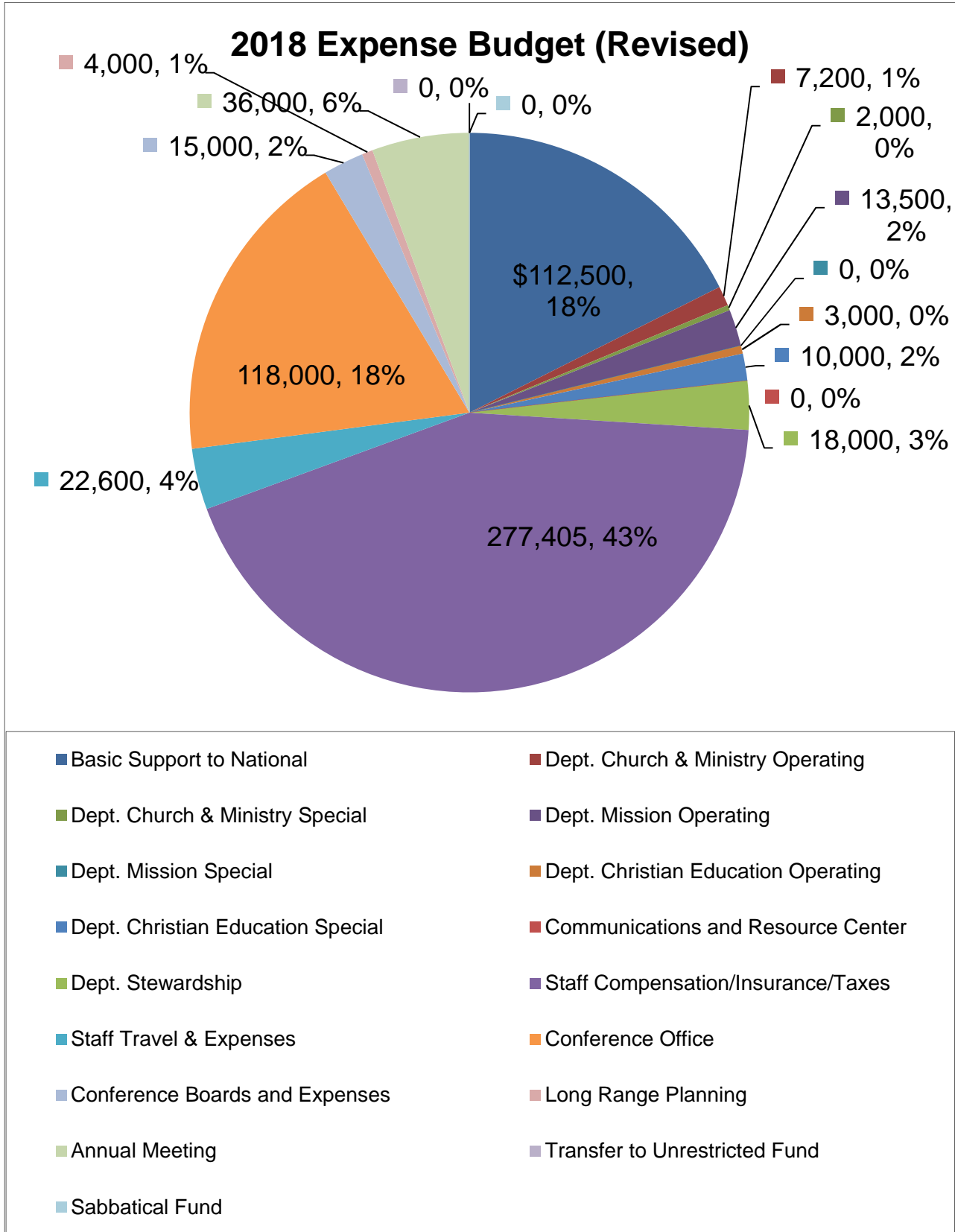

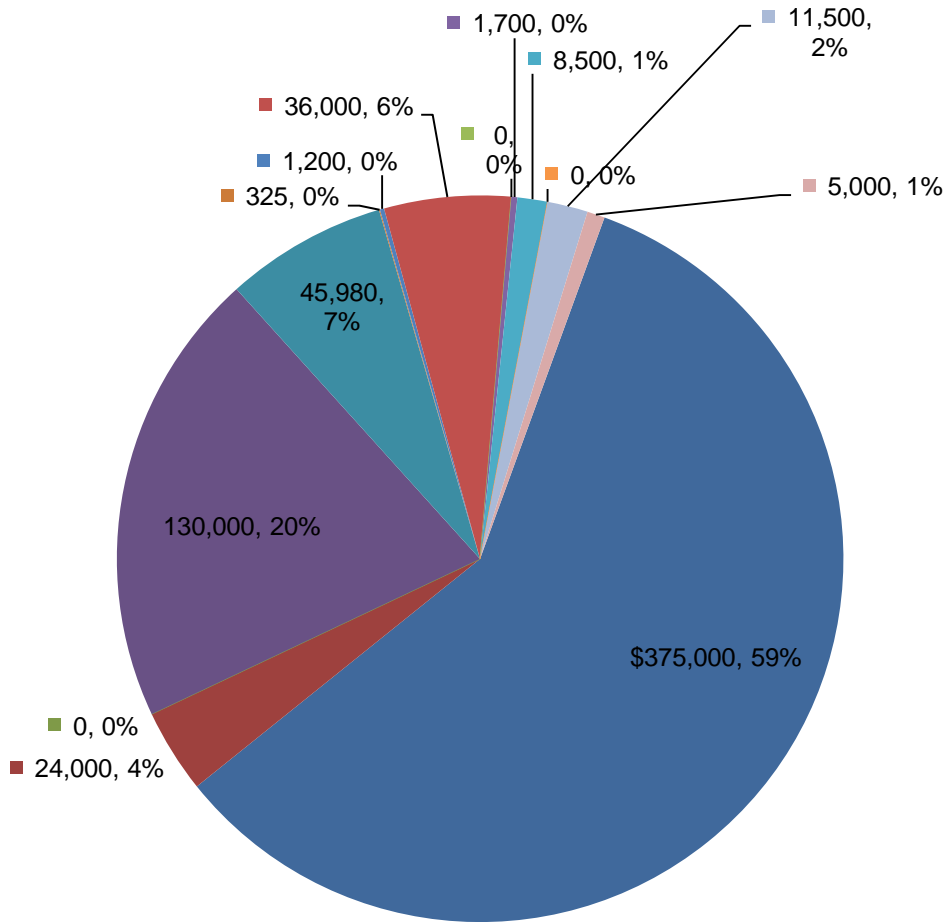
